Status Animarum Update

So far, 80 parishes of the 152 due (53%),- have submitted their 2025 Status Animarum. We appreciate all your hard work and time. The Status Animarum is due **July 31st.** We had several parishes that have emailed the signed verification form and parish Household/scatter report but have not completed the Status because they did not hit the "Submit Annual Report" button in PHOL. Please remember to select the "Submit Annual Report" before emailing the signed verification form and Household/Scatter Report. Please refer to the Year End Checklist in PHOL on the procedures tab to view the status of your Status Animaurm submission. It is **not** necessary for parishes to complete the Internal Questionnaire at this time. If you need assistance with the Servant Keeper groups, sacrament recording or the submission process please contact Parish and Curia Integration.

For those who have not yet submitted, we remind you to take the time to carefully check all sacraments entered in Parish Helper OnLine against your registers. Look for misspelled names, duplicate entries, missing information, minister of sacrament not listed with proper title, females not recorded with maiden name and incorrect dates. If you discover any errors on your Baptism, Confirmation, or Marriage registers after you have submitted the Status Animarum, please contact Parish and Curia Integration to have your Status Animarum reset at 314.792.7660 or ParishCuriaIntegration@archstl.org.

Follow-up letters from the vicars will be going out in early September to parishes that have not submitted the Status Animarum and the required documents.

Fiscal Year-End Preparation

As presented at the July Curia Connections meeting and included in the post-meeting follow up communications through the Vicariates, year-end financial reviews will be conducted by each Vicariate's Finance Liaison and are scheduled to begin on August 15th. Status Animarum Sacrament Corrections

Parishes who submitted their Status Animarum sacramental records with misspelled names, duplicate entries, missing information, minister of sacrament not listed with proper title, females not recorded with maiden name and incorrect dates will be contacted by the Parish and Curia Integration Office via the parish email. Please make the necessary correction and resubmit your Status if directed to do so by Parish and Curia Integration. We thank you for taking the time to ensure your parish sacraments are recorded completely and accurately.

Servant Keeper Cloud News

The Parish and Curia Integration team is focused on helping parishes run more smoothly and securely. When we were notified that Servant Keeper would stop supporting all local (non-cloud) versions as of May 2025, we took action to ensure your data remains protected and your operations uninterrupted. Starting July 1, 2025, the Archdiocese has partnered with Servant Keeper to provide Version 8 Cloud – Better to all parishes at no cost.

What does this mean for you?

• If your parish is already using Version 8 Cloud: Great news—you'll continue using the system as you do today, but you will no longer receive a monthly or annual bill. If your parish is using a local (non-cloud) version: Servant Keeper's White Glove Service will convert your data to the cloud for free. These conversions are scheduled individually by Servant Keeper staff, and training and support will be provided every step of the way by both Servant Keeper and our Parish & Curia Integration team. - Online Giving with Text-to-Give. You have the option to migrate to Servant Keeper's Online Giving and Text-to-Give at any time.
 - If your parish is currently using another e-giving provider you may continue to do so with the option to migrate to Servant Keeper in the future.
 - You may choose to use only Servant Keeper's Text-to-Give feature and stay with your current e-giving provider.

2025-2026 EPV Grant Process

Ensuring Parish Viability grants, awarded on an annual basis, are grants from the Archdiocese of St. Louis to parishes that have experienced demographic change to assist with capital project, debt, or evangelization efforts.

The process for Ensuring Parish Viability grants will launch in August with a communication from Archbishop Rozanski to pastors inviting those eligible to consider applying for a grant. The timeline is below.

Ensuring Parish Viability (EPV) Grants Timeline

- August 11 EPV process begins with email from Archbishop Rozanski to Pastors. EPV grant applications become available.
- September 5 Parishes should request applications by this date to allow time to complete the application.
- October 10 Deadline for application submission.

Helpful tip: Submit your applications early if you can. Any application received after October 10 will be denied or possibly considered as a lower priority.

To give your parish the best chance of success, and to avoid having your application returned for correction, please be sure to use the helpful checklists provided with the application. Incomplete or incorrectly formatted applications cannot be accepted. Certificate of No Tax Due

Several parishes have upcoming events requiring a liquor license and need a Certificate of No Tax Due. The Missouri Department of Revenue requires each parish to request its own letter. <u>Click here</u> for more information and instructions to apply for your copy. The Missouri Department of Revenue mails the Certificates to Linda Albrecht at the Curia. She then scans and e-mails the certificate to the parish. The Certificate of No Tax Due from the Missouri Department of Revenue required for the Liquor License application must be dated within 90 days of the Liquor License application date. The parish event date does not have to be within 90 days of the Certificated of No Tax Due.
