- 1) Ongoing effort since the outset to identify, obtain, and equip permanent vicariate office space resulting now in the intent to purchase the former St. Robert Bellarmine rectory
- 2) Ongoing direction and support for staff members and vicariate liaisons based on the Archbishop's vision that curial ministries and services which support parishes, pastors, and parish staff be decentralized to better and more effectively support and enhance parish life particularly in the areas of evangelization and social outreach.
- 3) Exploration of possibility to expand Evangelization and Pastoral Ministry Staff with interns from Augustine Institute and/or seminarians from Kenrick-Glennon.
- 4) Provided counsel, as requested or needed, to pastors involved in parish subsumption as pending appeals are resolved and to pastors engaged in leading multiple parishes for the first time.
- 5) Provided counsel, as requested or needed, to parochial administrators leading parishes for the first time.
- 6) Provided counsel, as requested or needed, to pastors regarding personnel issues related to parish and school staffing
- 7) Provided pastors/priests support and counsel, as requested or needed, regarding clergy personnel matters or the receipt of negative correspondence
- 8) Provided substitute sacramental assistance, as needed or requested, when priests have been ill or away from the parish for vacation or retreat.
- 9) Presided at 12 celebrations of the Rite of Installation of a Pastor
- 10) Conferred the Sacrament of Confirmation for children at 7 parishes
- 11) Provided counsel to pastors, reviewed the intended scope of work, and facilitated the process of granting permission for extraordinary expenditures, capital campaigns, capital projects, and/or loan acquisition for many parishes.
- 12) Ongoing involvement with pastors and parish building committees and town hall meetings of four parishes regarding \$10million+ capital improvement or expansion projects.
- 13) Ongoing service as archdiocesan point of contact with Benedictines at the Abbey of Sts. Louis and Mary and the Sisters of the Most Precious Blood (O'Fallon).
- 14) Accepted invitations from various parishes/groups to preside at special occasion liturgies or gatherings

- 18) Engaged in consultation with 10 pastors with schools affected by the new Archdiocesan Statute concerning viability of schools

- 19) Engaged regularly with the Office of Communications in response to media concerns regarding the vicariate(s), parishes, etc.

- 1) In March, 2025, the three Vicariate Directors of Operations were provided specialized access and training as ArchHR "super users", able to assist Human Resource personnel on many levels. In addition to directly contributing to clearing much of the hiring/onboarding backlog, I sat on several steering committees formed to address the stabilization and optimization of the ArchHR system, assisted with the development and communication of enhanced recruiting processes, and provided first-level support to parish leadership experiencing difficulty or having questions regarding ArchHR operations.
- 2) Beginning in April and with the support of the newly formed Talent Acquisition & Recruiting Team, I have provided ArchHR process review/training on location for 50% of the Western Vicariate parishes and/or schools, with participants including parish/school Business Managers, principals, and other staff directly involved in the hiring process. #### **Continued/Ongoing**

- Utilizing the same Flocknote platform, we issue periodic alerts containing urgent and/or targeted messaging from curia agencies and ministries as needed/requested, most particularly information regarding ArchHR, Benefits and Open Enrollment, Finance/Payroll updates, and various archdiocesan initiatives such as Missionaries of Joy.
- Develop and administer Curia Connections, an accessible, inclusive quarterly meeting established to provide parish office staff a professional forum to connect with one another and receive timely and informative presentations from curia offices and ministries.
- Regular attendance of Business Manager meetings (an informal group of parish professionals who meet semi-monthly for the purpose of idea exchange and fellowship).
- Continue to serve as the initial point of contact for parishes and general laity requiring support from/through the vicariate offices, manage general vicariate office operations and provide administrative support to Episcopal Vicar, Vicariate Directors, and Vicariate Liaisons, and coordinate renovation efforts to convert the former rectory of St. Robert Bellarmine into permanent vicariate office space.

In seeking greater alignment with the Archdiocese and striving to serve every square mile in each parish boundary, Catholic Charities continues to seek new ways to provide services and partner with agencies to do the same. To this end in the Western Vicariate, the following occurs monthly:

- Participate in monthly meetings with the Franklin County Homelessness Task Force and Franklin County Community Resource Board to collaborate with agencies to meet resident needs. Agencies include: Franklin County Health Dept, Ability, Compass Health, Jefferson-Franklin Community Action Corporation: EZMO/Vital ID, VA, Empac, Salvation Army, Life's River, Harvest Table, Prevent Ed, Union School District, Peace Lutheran Church, SVDP, Turning Point, CASA, SE Behavioral Health, ALIVE Court Advocacy, Foundations 4 Franklin County, Confident Kid Dental Charity, AlAnon, NUUR, LSEM, St. Patrick Center, Grace's Place, Washington Emergency Relief Fund, Gateway to Hope, Children's Advocacy Center, Hope 4 Franklin County Coalition, Neighbors United Undoing Racism, Mercy, etc.
- Resource Boards - Regularly attend monthly meetings of four county Resource Boards to build relationships/provide social outreach to the numerous organizations and agencies serving each county: Franklin County Community Resource Board, Franklin County Homeless Task Force, Lincoln County Resource Board, and the Community Council of St. Charles Council.
- Participate in monthly meetings with Lincoln County Resource Board to collaborate with agencies to meet resident needs. Agencies include: Bridge of Hope, F.A.C.T., Crisis Nursery West, Youth In Need, TCAC, St. Louis Counseling, DART Coalition, Troy R-III School District, Prevent Ed, SJA, CHN, Lincoln/Pike County Children's Division, 45th Circuit Children's Division, Lincoln County Sheriff's Office, Thrive-Best Choice, etc.
- Participated in NECAC Housing Summit in Hannibal to partner with various agencies and to advocate affordable housing.
- Presented to St. Vincent de Paul Assumption BVM Conference.
- Collaborated with St. Vincent de Paul Society Conferences to help serve neighbors in need.
- Collaborated with The Care Service on providing services to neighbors in need, particularly in terms of housing, case management, counseling, and food pantries in the area.
- Met with St. Francis Xavier College Church to determine possible locations where communities and agencies might be trained to run an ID assistance program.
- Connected with 50+ different community agencies to understand what they do, issues they are facing and to build collaboration opportunities.
- Answered over 300+ Request for Care emails through ccstl.org website.
- Responded to calls from parishes requesting assistance in locating services for parishioners.
- Responded to calls from SVdP and other agencies requesting assistance in locating services for neighbors in need.

- Collaborated with Catholic Charities Ministries, SVdP, and partner agencies to collect information from victims of spring tornadoes at the Multi-Agency Resource Center in Franklin County.
- Collaborated with Catholic Charities Ministries to begin to respond to over 2000 requests for assistance from victims of the May 16<sup>th</sup> tornado in St. Louis City/County: collaboratively created a disaster recovery call center, trained and managed volunteers, and began collecting information and providing assistance and resources.
- Below are examples of how the CC Navigator provides direct help to those in need:
  - Assisted a single mother of four kids in Lincoln County with replacing her roof which had sustained hail damage and was leaking water into her house jeopardizing housing. Through the Helping Hands grant and in partnership with Bridge of Hope LC, Sacred Heart's St. Vincent de Paul, and the contractor, she was able to replace the roof and stabilize her housing.
  - Assisted a man and his family with five kids with rent after his employer mistakenly overpaid him and then garnished multiple checks. The garnishment led him to be unable to pay rent and he was struggling to catch up, jeopardizing his housing. Partnering with J&A Care Service, Sacred Heart St. Vincent de Paul, and NECAC, Catholic Charities Helping Hands was able to help him pay rent and stay current on all his bills again.
  - Assisted a man and his daughter who were moving into an apartment and needed furniture, specifically a bed and living room furniture. Assisted with a non-profit referral to The Bridge for furniture and set up a date for the client to find a bed.
- Support the Archbishop's stated goals: 1) Strengthen Catholic and ministerial identity, 2) Integrate and become essential in All Things New, and 3) Grow the number of lives we serve.
- Catholic Charities, supported by the Navigator, funds leadership for Bridge of Hope shelter in Lincoln County and continues to follow up to ensure communities utilize the resources.
- Catholic Charities, supported by the Navigator, funds leadership for Life's River shelter in Franklin County and continues to follow up to ensure communities utilize the resources.
- Catholic Charities: Met with Parish Ambassadors and Catholic Charities Ministry leaders to learn about many of the programs and services offered and the various projects that are happening within parishes to support CC and the community, attended and provided insights at the Catholic Charities Visioning Workshop in April, and have encouraged pastors we've met with to bring in various Catholic Charities training:

## **Social Outreach and Catholic Charities - Collaborative Efforts as a Western Vicariate Team**

- 3) Mercy Community Health Council - Attending two meetings per month via Zoom to develop a knowledge base of healthcare resources to share with pastors, parishioners, and people within parish boundaries, including but not limited to Substance Use Recovery Clinic (including a virtual program), Narcan Vending Machines, Collaborative Behavioral Health Care Management, Little Food Pantries, Vital Documentation for patients, Health Shelves (access to fresh vegetables for seniors), and Dispensary of Hope (prescription medications for those without insurance).
- 4) Participate in Community Council of St. Charles County Network Luncheons to develop relationship and partner with: The Care Service, The Sparrow's Nest, Compass Community Health, Child Advocacy Center, LDS Church, Agape Community Outreach, Aging Ahead, Birthright, Delta Center, NAMI, NECAC, Nurses for Newborns, SVdP, Turning Point, Youth In Need, etc.
- 5) Participate in monthly St. Charles County Housing Team meetings to advocate for and work on affordable housing initiatives.
- 6) Participate in St. Vincent de Paul Northeast District Homeless Meetings.
- 7) Met with Northwest District President of the St. Vincent de Paul Society to help strategize how to keep Vincentians engaged when there are many within a conference, how to invite parishioners to become Vincentians, how to support and collaborate with Conferences.
- 8) Initiated conversations with St. Clare Catholic Church in St. Clair to learn about their Catholic Services organization and plan for the possibility of co-locating multiple services and providing resources to the community.
- 9) Reached out to Fr. Nord and Fr. Winker to ensure their communities had resources immediately after the March tornadoes.

  - EZMO Driver Program, which provides those in need transportation to doctor appointments, grocery stores, etc., while providing volunteer drivers a way to earn money.

The 2024–2025 ministry year was marked by transition, resilience, and renewed commitment. Amid significant staff turnover—including the departure of the director and multiple team members—the Office of Youth Ministry remained steadfast in its mission to support parish leaders, form young disciples, and create meaningful encounters with Christ across the Archdiocese. With the appointment of a new director in January, we entered a new chapter shaped by collaboration, strategic outreach, and deeper investment in parish youth ministry leadership.

**Regional Formation & Leadership Development** - This year, we prioritized accessible, high-impact formation and leadership development throughout the archdiocese. By intentionally offering regional opportunities in each vicariate—while keeping events open to all—we worked to meet parish leaders where they are and build unity around a shared mission.

**Key initiatives included:**

- **Youth Ministry Training Day:** Formation on the *Listen, Teach, Send* framework, trauma-informed care, and liturgical engagement.
- **Monthly Leader Gatherings:** Topics included leadership development, ministry planning, service, and best practices in middle school ministry.
- **Advent & Lenten Days of Prayer:** In collaboration with partners in faith formation.
- **Annual Youth Leader Retreat:** A weekend of prayer, reflection, and spiritual growth for all youth ministry leaders and teams.

**Raising Up a New Generation of Disciples** - Our office remained committed to creating vibrant, Christ-centered opportunities for youth to grow in discipleship, community, and vocational awareness.

- **The Middle School Summit** (Nov. 7): Over 1,600 middle school youth explored the universal call to holiness alongside priests, deacons, seminarians, and religious.
- **Day of Discipleship** (Nov. 9): Focused on Marian spirituality and leadership for 7<sup>th</sup> and 8<sup>th</sup> grade girls.
- **Day of Recollection** (Oct. 26): Focused on faith through the discovery of Mass, the Rosary, games for youth earning the Ad Altare Dei or Pope Pius XII religious awards.
- **Totus Tuus Summer Program** (June & July): Four local missionary teams served 22 parishes/pastorates across the archdiocese, combining fun with solid catechesis and faith witness.

- **Steubenville Conferences** (July): 8,500 youth and leaders gathered over two weekends for powerful worship, catechesis, and Eucharistic encounter.
- **Scouting as Youth Ministry:** We celebrated over 130 youth at Religious Awards Sunday, with additional awards distributed at the parish level. Catholic Mass was regularly celebrated at summer scout camps, and our leadership team maintained a strong presence at the council level to advocate for Catholic Scouting.

**Collaboration Across Ministries** - We continued to strengthen collaboration with other archdiocesan offices, working to ensure that youth ministers and volunteers are formed, supported, and present across a variety of pastoral efforts. These events enhanced formation, built connections, and reinforced that youth ministry is an integral part of the Church's broader mission.

**Opportunities and Plans for 2025–2026** - In 2025–2026, the Office of Youth Ministry will build on the momentum of this past year with a renewed focus on leadership formation, parish and vicariate outreach, and intentional collaboration. Rooted in missionary discipleship, our efforts will expand access, strengthen parish engagement, and form young leaders equipped to serve with purpose and joy.

#### **Key Initiatives and Areas of Focus:**

- **Summer Evangelization:**  
Totus Tuus will return for seven weeks across the archdiocese providing a resource and program to 22 parishes/pastorates, with plans to expand the number of teams in 2026, which will allow for us to serve up to an additional 7 parishes/pastorates. Steubenville STL Mid-America will again welcome thousands of teens over two weekends for a powerful encounter with Christ.
- **Formation & Ongoing Support:**  
Monthly Youth Ministry Gatherings will rotate across vicariates to remain accessible and

responsive to local needs while welcoming leaders from across the archdiocese. We will offer Advent and Lenten Days of Prayer, along with a retreat weekend for youth ministry leaders and teams. This year's annual training day will be offered in collaboration with Life Teen, featuring nationally recognized speakers and practical support.

- **New Youth Initiatives:**

We are developing new efforts focused on youth leadership formation and expanding opportunities for middle school ministry—empowering young people to lead, serve, and grow as missionary disciples.

- **Outreach and Accompaniment:**

We remain committed to meeting leaders where they are through intentional outreach, listening, and customized support. New project teams will engage parish youth ministry leaders directly, helping to shape resources and address emerging needs.

- **Archdiocesan Bicentennial Collaboration:**

As we celebrate the 200th anniversary of the archdiocese, we will actively engage youth and ministry leaders in key events, ensuring that the young Church is represented and connected to this historic milestone.

#### **Responding to Parish Needs** - Areas of need expressed at this time:

- **Partnering with Parents:** Parents are the primary evangelizers of their children. Parish youth ministry leaders are seeking tools and strategies to actively engage parents as key partners in the faith journey of their teens.
- **Supporting New Leaders:** As more parishes welcome new or volunteer youth ministers, there's a growing need to help pastors and leadership teams understand how to support them—through mentoring, clear expectations, and accessible formation.
- **Clarifying the Vision for Youth Ministry:** Parishes are discerning what youth ministry looks like in their context—be it traditional programming, small groups, or regional collaboration. Supporting parishes to develop models that fit their community.
- **Ongoing Formation for Leaders:** Sustainable youth ministry depends on well-formed leaders. There is a need to further develop training and formation that is practical, flexible, and responsive to parish realities.

These efforts reflect our commitment to a mission-driven, responsive approach to youth ministry—one that strengthens parish life, equips leaders, and walks with young people across the Archdiocese of St. Louis. Our goal is to be a true partner to every parish and vicariate, offering practical support and listening closely to local needs to help build sustainable, mission-rooted models of ministry.
